# 5.1.2 RESEARCH ETHICS PROCEDURES

## **ENABLING LEGISLATION + LINKED POLICIES**

5.1 Research Administration, Ethics, and Conduct Policy.

### INTENT OF PROCEDURES

These procedures are intended to promote and advance a high standard of ethics in research at the University that involves human participants. These procedures will identify responsibilities for maintaining these standards.

These procedures are expected to be followed by anyone who is engaged in any research activities (funded or not funded) that are supported through University equipment, staff, or students. All members of the University involved in research are expected to adhere to the highest standards of ethical conduct and in a manner consistent with their research disciplines.

The operations of the Emily Carr University Research Ethics Board (ECU-REB) follow Standard Operating Procedures (SOPs) listed in the Table of Contents below. The ECU-REB SOPs are drawn from the most current version of N2/CAREB "Observational Health" Standard Operating Procedures and modified to reflect the Emily Carr University context. They adhere to the most current version of Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans (TCPS).
