### I. ADMINISTRATIVE BUSINESS

Call to Order – Trish Kelly, Chair, called the meeting to order at 10:06 a.m.

## II. BUSINESS

### 1. Senate Chair's Opening Remarks

T. Kelly welcomed new Student Senators: K. Bashir, C. Fears, Y. Kucukakyuz and thanked I. Tripathi for returning to her third year as a Senator. She also introduced J. Turner, Interim Dean, Faculty of Culture + Community and mentioned L. Hollander as the new appointed staff Senator who was unable to attend the meeting.

K. Bird noted that a Special Senate meeting is expected to be called sometime in October to approve the November 2023 graduand list.

### 2. Election of Vice Chair of Senate

K. Bird, Registrar and Secretary to Senate, outlined the role of Vice Chair of Senate and T. Kelly, also shared additional notes on its importance to Senate, including that the Vice Chair chairs the Senate Budget Committee.

The Registrar called for Nominees to serve as Vice Chair of Senate. D. Achjadi and Y. Kucukakyuz were nominated. Both candidates accepted the nomination and provided a few words, an overview of their experience and interest in the position.

The Registrar conducted a confidential balloted election, scrutinized by R. McGee. I. Tripathi was asked to share her vote with N. Shin via zoom to be written on the ballot and handed to R. McGee.

D. Achjadi was elected as Vice Chair of Senate. K. Bird to notify D. Achjadi of the result.

5. Presidential Search Update

N. Himer provided a brief update regarding the Presidential Search. She reported that L. St. Pierre has been selected by Senate as the Senate representative on the Presidential Search Committee. N. Himer read the membership of the final committee indicated that it will also be posted on the Presidential Search webpage. There will be regular updates to Senate as the search process progresses and regular updates will also be shared on a webpage dedicated to the Presidential Search. She encouraged members of Senate to check the website for updates.

6. Course Change Proposals

H. Tsang, Chair of CPR was unable to attend the meeting and C. Martin reported out on his behalf.

As part of program review and implementation process, the first set of proposals will align learning outcomes and objectives to ECU's framework. They were passed unanimously by CPR at the April 5, 2023 meeting.

The second part of the proposals were approved May 3, 2023 at CPR. It is also work that emerges out of the program review and the implementation of an action plan for a new course and a new minor both in the BDes ecological practices.

C. Martin informed Senate that the new course and design minor in ecological practices has been a part of the trajectory within BDes. It is a curricular space that has the potential to expand. Many different stakeholder groups were consulted as part of the process.

It was also noted that CPR discussed reviewing minors more broadly at ECU and the need to implement a better framework for minors.

- Direct Entry model: articulation of first year core studio learning outcomes in relation to Dynamic Media frameworks; and
- Land acknowledgements in course outlines.

2023-24 Priorities:

1. Mapping Learning Outcomes to 200-400 core and required courses.
2. PRW and course structure review.

C. Martin also reported that additional 2023-24 priorities involve developing a multi-year DDM hiring plan proposal, as well as, collaborating with Communications/IT teams to advocate for improving website infrastructure in relation to program representation and faculty website presence.

## 8. Senate Chair's Report

T. Kelly provided the following highlights:

- Thanked K. Bashir for bringing forward the idea of hosting a welcome week for students, which was highly successful;
- The draft strategic plan is progressing and key priorities will be shared with the Board and Senate at a later date for further conversations before the plan is finalized. The plan is expected to be complete by the end of the year with an action plan that will hold us accountable to implementing goals and priorities;
- The university created an Accessibility Advisory Committee to develop an accessibility plan for the institution. The committee will look for ways to accommodate people with disabilities by providing a framework to identify, remove and prevent barriers to accessibility in accordance with the Accessibility BC Act. Updates regarding the accessibility plan will be posted on the website;
- Continuing to connect with external stakeholders, donors and government and have conversations about our financial situation, EDI, student housing and international students;
- The Totem Pole Unveiling taking place on Friday, September 28, 2023 with all three Master Carvers: Dempsey Bob (Tahltan-Tlingit), Stan Bevan (Tahltan-Tlingit and Tsimshian) and Lyonel Grant (Māori and Pakeha); and
- In recognition of the National Day for Truth and Reconciliation, she welcomed Senators to attend an ECU community gathering at the Caf at 12:00pm on Friday, September 29<sup>th</sup> where T. Kelly will share a few words and take a moment to reflect on how we can each commit to advancing the necessary work of reconciliation.

T. Kelly thanked K. Bird as this is his last Senate meeting before retiring. She expressed her gratitude for his 22 years of services to the university over which he helped to foster a collaborative community and recognized his unwavering dedication.
